### MINUTES

1. Call to Order and Pledge of Allegiance

The meeting was called to order at 6:00 pm

2. Approval of the minutes of January 26, 2015, meeting

A motion was made by Peter Castonguay to approve the minutes as presented; second by Megan Dion.

3. Reports

- a. Highway Foreman

- Residents are reminded that plowing snow across the road is illegal and violators could face a fine of \$153.00 per incident.

- b. Treasurer Report

- Excise is slightly less than for January last year
- Tax money still coming in
- 30 day notices have been sent out to 22 property owners pending foreclosure. If taxes are not paid by close of business on Monday, March 9, 2015, the Town will foreclose.
- We are having a workers compensation audit tomorrow

- a. Donald Castonguay – First Responder Presentation

Ben Guild presented information on a first responder class that will be hosted by Livermore Fire Department. This will enable firefighters to act as a secondary responder service. Fire fighters have found that they are responding to a lot of calls for Northstar. There are currently only 3 certified first responders on the department. The cost per student will be approximately \$610.00. Medical supplies will be provided by Northstar. The fire department would have to buy suction unit. The nationally certified training will be a 2-month long class and will be open to public. There is a 15 student limit. Jay and Livermore Falls Fire Departments have fire fighters who have expressed an interest in attending.
